That I, JAMES P. MOORE in the State aforesaid,
in consideration of the sum of Nine Hundred Seventy-five and no/100 ----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. H. MAULDIN, his heirs and assigns, forever:

ALL that lot of land situate on the East side of Woodridge Circle, near the Town of Mauldin, in Greenville County, South Carolina, being shown as Lot No. 65 on plat of Windsor Park, made by R.K. Campbell, Surveyor, March 29, 1960, recorded in the RMC Office for Greenville County, S.C. in Plat Book RR, Page 25, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Woodridge Circle at joint corner of Lots 65 and 66 and runs thence along the line of Lot 66, S. 71-0 E., 142.2 feet to an iron pin; thence along the line of Lot 64, S. 8-35 W., 34.5 feet to an iron pin; thence along the line of Lot 53, S. 19-55 W., 90.3 feet to an iron pin; thence along the line of Lot 52, N. 71-0 W., 130.6 feet to an iron pin on the East side of Woodridge Circle; thence along Woodridge Circle, N. 19-0 E., 120 feet to the beginning corner.

THIS property is conveyed to the grantee subject to the restrictions applicable to Windsor Park recorded in Deed Book 647, Page 237, RMC Office for Greenville County, S.C.

THIS is a portion of that property conveyed to the grantor by deed of Nellie M. Smith dated April 15, 1959 recorded in Deed Book 621, Page 450. TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

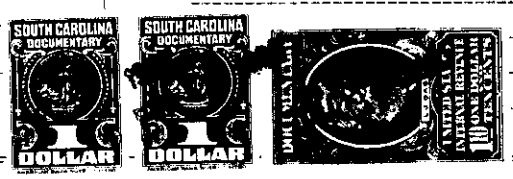
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.
