That I, M. W. Fore in the State aforesaid, in consideration of the sum of Six Hundred Eighty & NO/100 (\$680.00) - - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. L. Smith and Cora Smith, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, in Gantt Township, being known and designated as Lot No. 79, as shown on a Plat of Brookwood, recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 27, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Gantt Dive, joint front corners of Lots 78 and 79 and running thence with joint line of said lots, S. 2-15 W. 165 feet to an iron pin, rear corner of Lot 56; thence with line of said lot, S. 87-45 E. 100 feet to an iron pin, rear corner of Lot 80; thence with line of said lot, N. 2-15 E. 165 feet to an iron pin in the South side of Gantt Drive; thence with said Drive, N. 87-45 W. 100 feet to the point of beginning.

NO residence to cost less than Five Thousand (\$5,000.00) Dollars shall be erected on said lots; no residence shall be erected on any lot nearer than thirty-five (35) feet to the front line; no residence shall be erected on any lot unless said lot has fifty, (50) feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS conveyance is subject to all easements and rights of way of record.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and their Heirs and Assigns forever.

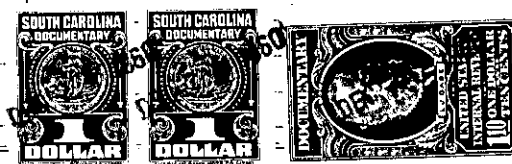
