BEGINNING at an iron pin at the joint corner of St. Mark Church Road and a 50 foot road and running thence along St. Mark Church Road S. 12-30 E., 118 feet to an iron pin at the joint front corner of tracts 4 and 6 and running thence N. 62-52 E., 359.7 feet to an iron pin; running thence S. 12-29 E., 239.4 feet to an iron pin and running thence N. 63-30 E., 275 feet to an iron pin joint rear corner of tracts 6 and 8 and running thence along the joint line of 6 and 8 N. 26-30 W., 357.8 feet to an iron pin on a 50 foot road and running thence along said 50 foot road S. 50-31 W., 340.1 feet to an iron pin; running thence S. 77-30 W., 221 feet to an iron pin, the beginning corner.

The Grantors and Grantee constitute all the heirs at law of Lorena A. Ayers.
