DUKE POWER COMPANY:

All that piece, parcel or lot of land situated, lying and being on the Eastern side of Buncombe Road, in Greenville Township, Greenville County, State of South Carolina, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Buncombe Road at the joint front corner of property herein described and that property now or formerly owned by Martin Kay Robertson, and running thence along the line of said Robertson property, N. 87-40 E. 207.4 feet to an iron pin; thence S. 4-17 E. 52.5 feet to an iron pin at the corner of property now or formerly belonging to Joe Burns; thence along the line of said Burns property, S. 87-40 W. 207.4 feet to an iron pin on the Eastern side of Buncombe Road; thence along the Eastern side of Buncombe Road, N. 4-17 W. 52.5 feet to the point of beginning.
