Received of the SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY ONE AND Dollars in consideration of which we (We) hereby grant said Company, its associated and allied companies, their respective licensees, successors and assigns, the right to construct, operate and maintain a line of communication consisting of such poles, wires, cables, conduits, guys, anchors and other necessary appurtenances as from time to time are required upon, across, over and/or under that certain tract of land situated in GREENVILLE County, State of SOUTH CAROLINA, to-wit: THAT TRACT OF LAND LYING NORTHWEST OF CLUB CIRCLE AND BOUNDED ON THE WEST BY J. GREEN AND ON THE NORTHWEST BY C.F. CATO TRUSTEE AND ON THE EAST BY MRS B.T. WHITMIRE.
