to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) W. Maurice Talley, his heirs and assigns forever:

All my right, title, and interest in and to: All those certain parcels or tracts of land situate, lying and being in Greenville County, State of South Carolina, Bates Township, approximately 1 1/2 miles Northwest of Locust Hill, being shown and designated as Tracts Nos. 2 and 3 on a plat of property of the H. Wells Talley Estate, prepared by John A. Simmons, Surveyor, dated March 18, 1961, recorded in Plat Book Vol. VV at page 91, R.M.C. Office for said County, and together containing a total of 25.65 acres. Reference to said plat and record thereof is hereby made for a more detailed description of said property.
