unto Elaine D. Childers, her heirs and assigns,

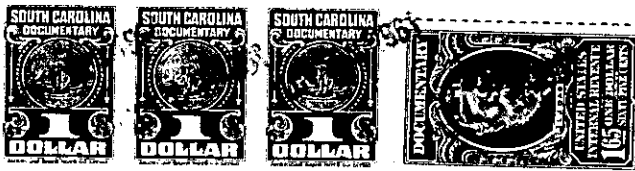

C., in Plat Book GG, at page 133, and ALSO, as shown on Plat of Property of Willis Lee Taylor, dated October 28, 1959, prepared by R. B. Bruce, Engineer, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the eastern side of Cool Brook Drive, joint front corner Lots 50 and 51, which iron pin is 227.2 feet southeast of the intersection of said drive with Fleetwood Drive; thence with the line of said lot N. 68-20 E. 215.4 feet to an iron pin in the rear line of Lot 42; thence with the rear line of Lots 42 and 43 S. 00-15 W. 132.3 feet to an iron pin at the rear corner of Lot 49; thence with the line of Lot 49 S. 85-04 W. 187.6 feet to an iron pin on the eastern side of Cool Brook Drive; thence with the curve of the eastern side of said Drive, the chord of which is N. 10-33 W. 70 feet to the point of beginning.

This property is subject to mortgage given to Sumner G. Whittier, as Administrator of Veterans Affairs, on which there is a balance due of \$13,210.35, said mortgage being recorded in Mortgages Volume 810, page 503.
