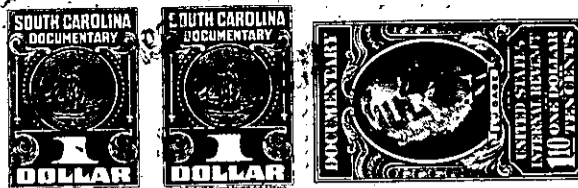

of PARIS VIEW, a subdivision as shown on a plat thereof recorded in the Office of the Register of Mesne Conveyances of Greenville County, in Plat Book VV, at Page 101, reference to which plat is hereby made for a more detailed description of said land.

Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

To have and to hold all and singular the Premises before mentioned unto the grantees hereinabove named, and their heirs and Assigns forever.
