That I, Albert Taylor, in the State aforesaid, in consideration of the sum of Six Hundred (\$600.00)----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James Everett Foster and Sylvia Virginia Foster the following-described property:

ALL that certain piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, South Carolina, shown and designated as Lot No. 19 according to plat of property of Albert Taylor, prepared by Terry T. Dill, October 15, 1954, recorded in the office of the R.M.C. for Greenville County in Plat Book HH, Page 173, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of White Horse Road Extension, joint front corner of Lots 19 and 20, and running thence along the joint line of said lots S. 2-47 E. 123.0 feet to an iron pin, joint rear corner of lots 17,18, 19 and 20; thence along the joint rear line of Lots 18 and 19, S. 83-43 W. 75 feet to an iron pin, joint rear corner of lots 18 and 19; thence N. 1-17 W. 106 feet to an iron pin on the south side of White Horse Road Extension; thence along the south side of said White Horse Road Extension, N. 70-12 E. 75 feet to the point of beginning.
