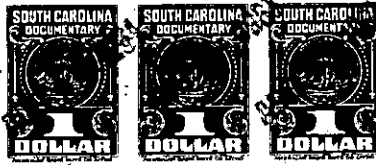

KNOW ALL MEN BY THESE PRESENTS, that **I, M. W. Fore**

in consideration of **Thirteen Hundred Twenty Five & NO/100 (\$1,325.00)** Dollars,  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto **Mavis Alice Barfield, her heirs and assigns forever:**

ALL that piece, parcel or lot of land in Gantt Township, being known and designated as Lot Nos. 14 and 67, of a subdivision known as Bel Aire Estates, as shown on a Plat thereof, dated May 1956, recorded in the R. M. C. Office for Greenville County in Plat Book KK, at Page 19, and having according to said plat the following metes and bounds, to-wit:

**LOT 14:** BEGINNING at an iron pin on Staunton Bridge Road, joint front corners of Lots 13 and 14 and running thence along the line of said lots, N. 88-21 W. 170 feet to iron pin line of Lot 67; thence running with line of said lot, S. 1-39 W. 86.2 feet to iron pin on Cumbahee Trail; thence running with said Trail, S. 88-21 E. 150 feet to iron pin; thence running, N. 43-21 W. 28.3 feet to iron pin; thence running with Staunton Bridge Road, N. 1-39 E. 66.2 feet to iron pin at point of beginning.

**LOT 67:** BEGINNING at an iron pin on Cumbahee Trail, joint front corners of Lots Nos. 66 and 67 and running thence along the line of said lots, N. 28-11 W. 205 feet to iron pin; thence running with rear line of Lots 12, 13 and 14, S. 1-39 W. 195.10 feet to iron pin on Cumbahee Trail; thence running with Said Trail, 104.4 feet to iron pin at point of beginning.

NO residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet or more frontage; no residence shall be built on any lot nearer than thirty (30) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; no business building shall be erected on any lot other than lots fronting on Staunton Bridge Road.

THIS conveyance is subject to all easements and rights of way of record.

GRANTEE to pay 1961 taxes.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s) heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s) heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
