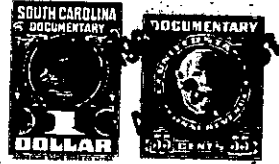

BEGINNING at an iron pin on Gandy Avenue, joint front corners of Lots Nos. 168 and 169 and running thence along the line of said lots, N. 86-0 W. 150 feet to iron pin; thence running with rear line of Lot 169, S. 4-00 W. 40 feet to iron pin rear corner of Lot 170; thence running with line of said lot, S. 86-0 E. 150 feet to iron pin on Gandy Avenue; thence running with Gandy Avenue, N. 4-00 E. 40 feet to iron pin at point of beginning.
