to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said BESS R. HENRY, her heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon, situate on the North side of Crescent Avenue (formerly Oliver Street), in the City of Greenville, in Greenville County, South Carolina, shown as Lot 68 and a portion of Lot 73 on plat of Alta Vista, made by R. E. Dalton, Engineer, June 1925, recorded in the RMC Office for Greenville County, S. C. in Plat Book "G", page 20, and having according to said plat and a recent survey made by R. W. Dalton, December 28, 1954, the following metes and bounds, to wit:

BEGINNING at an iron pin on the North side of Crescent Avenue, at the corner of Lots 68 and 69, and running thence with the line of Lot 69 and through Lot 73, N. 4-15 E., 254.3 feet to an iron pin in line of Lot 74; thence with the line of said lot, S. 85-45 E., 54.4 feet to an iron pin; thence along the line of property now or formerly owned by W. C. McDaniel, S. 1-00 W., 254.9 feet to an iron pin on the North side of Crescent Avenue; thence with the North side of Crescent Avenue, N. 85-40 W., 68.2 feet to the beginning corner.
