NOW, THEREFORE,

KNOW ALL MEN BY THESE PRESENTS: That ~~for and to consideration of~~ in order to correct ~~the error~~ ~~of the plat recorded in Plat Book H, Page 471,~~ Christ Church Cemetery, a corporation of South Carolina, ~~by and for the~~

~~does by these presents grant, bargain, sell and release unto the said~~ Marvin Rush Thackston and Ethel K. Thackston a lot or parcel of ground, including perpetual care, in Christ Church Cemetery, Greenville County, South Carolina, designated as Lot No. 1 Section 60; the same being described and designated as above, in accordance with plat recorded in R. M. C. Office for Greenville County in Plat Book ~~H, Page 300.~~ QQ, Page 179. (72 Sq. Ft.).

It is distinctly understood that said lot is to be used exclusively for the burial of human bodies of the white race, and is sold and conveyed subject to all rules and regulations printed on the back hereof, and any additions or amendments for the government of the Cemetery which may hereafter be adopted.

TO HAVE AND TO HOLD the above granted property to the said Marvin Rush Thackston and Ethel K. Thackston, their

heirs and assigns forever; subject, however, to the restrictions and limitations above referred to.

AND Christ Church Cemetery does hereby bind itself and its successors to warrant and forever defend the said premises to the said Marvin Rush Thackston and Ethel K. Thackston, their heirs and assigns against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof; subject, however, to the restrictions and limitations herein contained.

IN WITNESS WHEREOF Christ Church Cemetery has caused this instrument to be signed by its President and its seal affixed this 1st day of November, 1961.

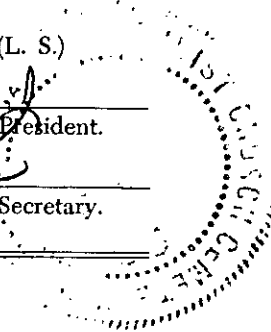

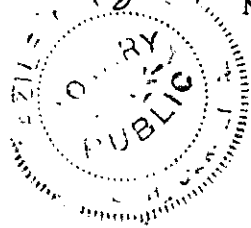
