to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Greenville County, its successor and assigns

All that piece, parcel or lot of land in Cleveland Township, Greenville County, State of South Carolina, being known and designated as Spring Court, a 50-foot road as shown on plat thereof made by Ferry Dill of the property of P. D. Jarrard, Sr. on October 20th, 1960 and described as follows:

BEGINNING on the Northeast corner of Lot 1 and following rear lot lines of Lots 2, 3, and 4 in a North Western direction; thence, along Lot 4 and between Lots 4 and 5 in a western direction to the Geer Highway, approximate distance of 658 feet. Also, a 40 foot drive between Lots 2 and 3 from Geer Highway to Spring Court, approximate 195 feet.

The above being a portion of the land deeded to me by E. Inman for H. C. Beattie, et al, recorded on the 28th day of September 1959, Book B, Page 694, also W. H. Beattie, et al, recorded 7th day of November 1959, Book 638 page 208.
