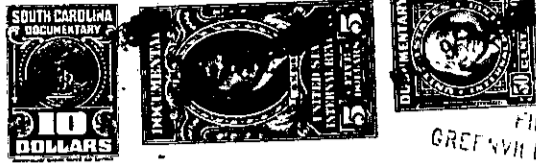

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto BEALY N. SPENCE, his heirs and assigns,

ALL that piece, parcel or lot of land with the buildings and improvements thereon,
situate, lying and being near the City of Greenville, County of Greenville, State
of South Carolina, being known and designated as Lot #3, Plat of Springview, which
plat is recorded in the RMC Office for Greenville County, S. C., in Plat Book BB,
page 161, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Farley Avenue, joint front corner
Lots 3 and 4 and running thence N. 1-02 W. 113.8 feet to an iron pin; thence S.
88-58 W. 115 feet to an iron pin; thence S. 1-02 E. 113.9 feet to an iron pin
on Farley Avenue, joint front corner Lots 2 and 3; thence along Farley Avenue
N. 88-54 E. 115 feet to an iron pin, the point of Beginning.
