in consideration of ONE THOUSAND FIVE HUNDRED AND NO/100-----(\$1,500.00)----- Dollars,

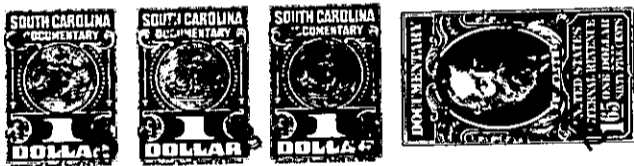
