Know All Men by These Presents:

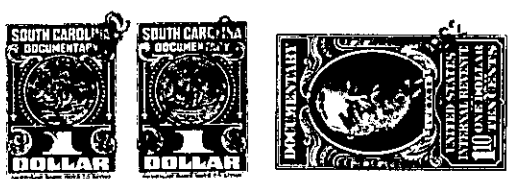
That I, Agnes M. Holliday, in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Joe Bud Smith and his heirs and assigns forever:

All that parcel or lot of land in Oneal Township of Greenville County, South Carolina, located about three miles north of the City of Greer and on the north side of Holliday Road, being shown as Lot No. 37 on a plat of subdivision known as HOLLIDAY HILL, made by John A. Simmons, Registered Surveyor, on April 25, 1961, and completed on August 5, 1961, plat recorded in the R.M.C. Office for Greenville County, and having the following courses and distances:

BEGINNING on an iron pin at the corner of Holliday Road and Motherwell Drive, and runs thence with the margin of Motherwell Drive, N. 4-00 E. 204.8 feet to an iron pin; corner with Lot No. 36; thence S. 86 E. 100 feet to an iron pin, corner of Lot No. 38; thence with the line of that lot, S. 4-00 W. 197.4 feet to an iron pin on Holliday Road; thence therewith S. 89-52 W. 100 feet to the beginning corner.
