Lorray M. Strandemo and Marjorie Strandemo,

All that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 16 on plat of Rosedale subdivision made by C. O. Riddle, February 1959, recorded in plat book QQ pages 112 & 113 of the RMC Office for Greenville County, S. C., and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of Rosemary Lane, the joint front corner of Lots 15 and 16; thence with the joint line of said lots S. 16-08 W. 200 feet to an iron pin; thence S. 73-52 E. 100 feet to an iron pin corner of Lot No. 17; thence with the line of said lot N. 16-08 E. 200 feet to an iron pin on the south side of Rosemary Lane; thence with the south side of said street N. 73-52 W. 100 feet to the beginning corner.
