KNOW ALL MEN BY THESE PRESENTS, that I, Alton J. Howell,

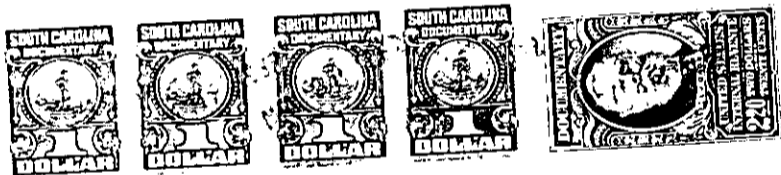
in consideration of Two Thousand and No/100 (\$2,000.00)----- Dollars,

All those pieces, parcels or lots of land situate, lying and being in Chick Springs Township, Greenville County, State of South Carolina, on the western side of Rose Garden Street and being known and designated as Lots Nos. 25, 26, 27 and 28 of Block "E" of Buena Vista as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "W", at Page 11 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Rose Garden Street at the joint front corner of Lots Nos. 24 and 25 and running thence along said Street, S. 9-43 E. 140.8 feet to an iron pin; thence S. 73-08 W. 145.7 feet to an iron pin; thence N. 13-17 W. 140 feet to an iron pin; thence N. 73-08 E. 156.4 feet to the point of beginning.

The above is the same property conveyed to the grantor by deed recorded in Deed Book 579, at Page 227.

As part of the consideration of this conveyance the grantee assumes and agrees to pay the balance due on the mortgage over the above property to General Mortgage Co. recorded in Mortgage Book 621, at Page 43, the balance now due and owing being \$7671.85.
