All that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 6, containing 1.14 acres, on plat of record in the RMC Office for Greenville County in plat book WW page 243 and having according to said plat the following metes and bounds:

Beginning at an iron pin on the southwest side of the right of way of Poinsett Highway, the joint corner of Lots Nos. 6 and 7; thence with the joint line of said lots S. 64-35 W. 216.8 feet to an iron pin on the northeast side of the right of way of Buncombe Road; thence with the northeast side of said Buncombe Road S. 46-48 E. 414.6 feet to an iron pin; thence N. 43-00 E. 51 feet to an iron pin on the southwest side of the right of way of Poinsett Highway; thence with the southwest side of said Highway N. 19-50 W. 103.2 feet to an iron pin; thence N. 24-00 W. 100 feet to an iron pin; thence continuing N. 26-40 W. 162 feet to the beginning corner.
