Know All Men by These Presents:

That I, Joann B. Howard in the State aforesaid, in consideration of the sum of One Hundred (\$100.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Gordon L. Sudduth & Nannie E. Sudduth, their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina County of Greenville, Oneal Township, about five miles North of Greer, S.C., lying on the Southern side of a community road that leads off State Highway # 14, and being part of the same land that was conveyed to Myra Pittman Wolfe by deed from T. L. & Beulah F. Forrester, January 11th, 1947, recorded in the Office of R.M.C. for Greenville County in Deed Book 306 at page 14, and having the following courses and distances, to-wit:

BEGINNING on a stake in the said community road, joint corner of the lot being conveyed by Myra Pittman Wolfe July 8, 1958, to James A. Howard, and runs thence, with the common line of the said two lots, S. 26-00 E. 20 feet to an iron pin on the southern bank of the said road; thence continuing with the same course for a total distance of 217 feet to iron pin; thence S. 63-55 W. 100 feet to an iron pin; thence N. 26-00 W. 217 feet to a stake in the said community road (iron pin back on line at 21 feet); thence with the said road, N. 63-55 E. 100 feet to the beginning corner, containing one half (1/2) acre, more or less.

This is the same property conveyed to me by deed from Myra Pittman Wolfe, dated July 8, 1958, and recorded in the R. M. C. Office for Greenville County in Deed Book 601, at page 354.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
