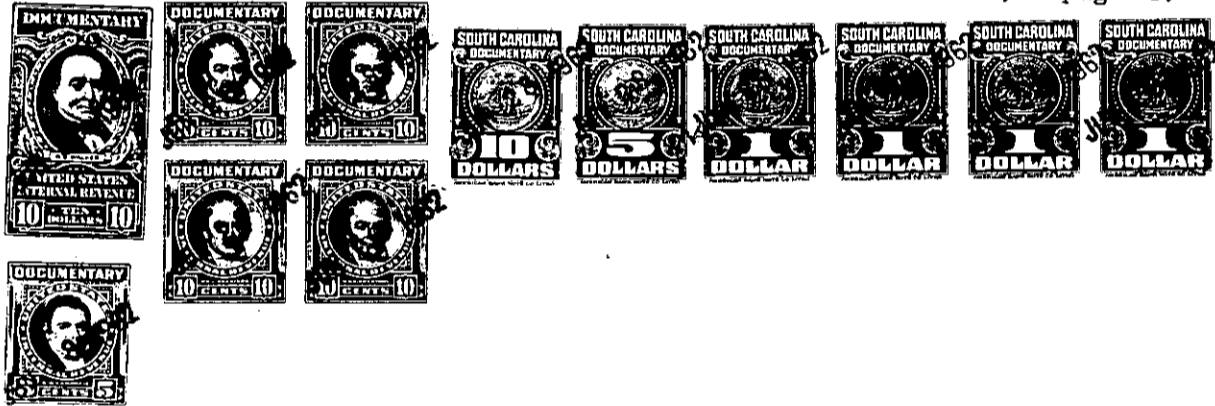
KNOW ALL MEN BY THESE PRESENTS, that I, Lloyd W. Gilstrap, of Greenville County,

in consideration of Nine Thousand, Five Hundred and No/100 - - - - - (\$9,500.00) - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Henry G. Staton, his heirs and assigns forever:

All those certain pieces, parcels, or lots of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lots Nos. 8 and 9 of a subdivision known as Paris Heights, according to a plat thereof prepared by Piedmont Engineering Service, November, 1950 and recorded in the R. M. C. Office for Greenville County in Plat Book Y, at page 65, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Pisgah Drive, joint front corner of Lots Nos. 9 and 10, and running thence with the joint line of said lots, S. 17-30 E. 150 feet to an iron pin at the joint rear corner of Lots Nos. 9 and 10; thence along the rear lines of Lots Nos. 9 and 8; S. 72-30 W. 209.3 feet to an iron pin on the eastern side of Base Hospital Road; running thence with the eastern side of said Base Hospital Road, N. 14-02 W. 125.5 feet to an iron pin in the intersection of said Base Hospital Road and Pisgah Drive; thence with the curvature of said intersection, the chord of which is N. 29-02 E. 36.4 feet to an iron pin on the southern side of Pisgah Drive; thence with the southern side of said Pisgah Drive, N. 72-30 E. 175.3 feet to the point of beginning; being the same conveyed to me by Ralph L. Johnston, et al. by deed dated May 24, 1962 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 699, at page 71.
