CERTIFICATE OF OWNERSHIP

Voyles** heirs and assigns for interment purposes only, subject to the condition, reservations and restrictions hereinafter contained, the following property situated in the Greenville Memorial Gardens in the County of Greenville, State of South Carolina, described as Lot No. **80-A** in Section **H, The Tower of Peace Graves 1-2** according to a map of the said Greenville Memorial Gardens filed in the Office of the Greenville Memorial Gardens, of said Greenville County, South Carolina.

THAT THIS CONVEYANCE, an all right, title and interest hereby conveyed in the property above described, is, and at all times shall be, limited to a right of interment, and is subject at all times to the rules and regulations and by-laws of said Corporation, in effect, now existing and/or which may be by it hereafter adopted, either by amendment, modification or the adoption of new ones, and which are specifically referred to and hereby made a part hereof in full; all of which are conditions, covenants and restrictions, and the liability upon the Grantee, his heirs, devisees, executors, administrators and assigns, shall be the limited liability as set forth in the contract for purchase.

Nothing herein contained shall be deemed to restrict the use of or the location of the Cemetery. Only the Grantor or its successors, in interest of the fee title, shall be bound by restrictions heretofore or hereafter placed upon the use of any portion of the Cemetery.
