BEGINNING at an iron pin on the east side of Saponee Drive at joint front corner of lots nos. 57 and 58 and running thence with the line of said lots N. 80-30 E. 180 feet; thence N. 9-30 W. 90 feet; thence S. 80-30 W. 180 feet to an iron pin on Saponee Drive; thence with Saponee Drive S. 9-30 E. 90 feet to the point of beginning.
