FERGUSON, His heirs and assigns forever:

ALL that certain, piece, parcel or lot of land in Bates Township, Greenville County, State of South Carolina, near Travelers Rest, and being known and designated as Lot Number 34 as shown on a revised map of Lots Numbers 34 through 47 of a subdivision known as Meadowbrook Farms, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book PP at Page 113, and having the following metes and bounds, to-wit:

BEGINNING at a point on the Southern side of Toler Road at the joint front corner of Lots 33 and 34 and running thence with the Southern side of Toler Road S 87-00 E 65.2 feet to a point, said point being the front corner of Lot 34; thence continuing with the Southwestern side of Toler Road S 34-34 E 190.7 feet to a point at the joint rear corner of Lots 34 and 14; thence N 87-00 W 181.3 feet to a point at the joint rear corner of Lots 33 and 34; thence N 3-00 E 151.3 feet to the point of beginning.
