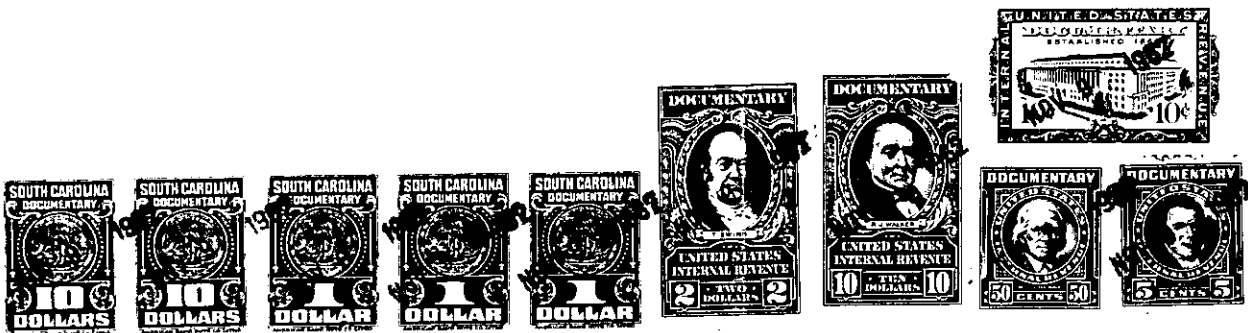
in consideration of the sum of Eleven Thousand One Hundred Fifty and no/100-----DOLLARS,
