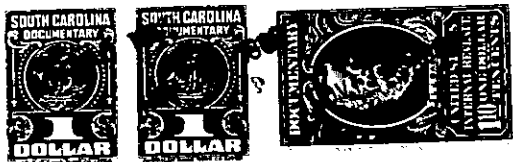

All that certain piece, parcel or lot of land, lying and being in Austin Township, Greenville County, State of South Carolina, located on the South East side of Log Shoals Road, at intersection with Fairlane Drive and having according to a survey and plat made by C. F. Webb, Surveyor on March 28, 1959, the following metes and bounds, to-wit:

BEGINNING at a point in the center of the Log Shoals Road (Iron pin at 28 feet on bank) and running thence S. 33-35 E. 262 feet from center of road to an iron pin; thence N. 46-12 E. 118.4 feet to an iron pin; thence N. 43-23 W. 259.5 feet to a point in the center of the Log Shoals Road; thence along center of road S. 44-24 W. 74.2 feet to an iron pin, the beginning corner, and being a portion of the same property conveyed to William J.
