All that piece, parcel or lot of land in Greenville Township, County of Greenville, State of South Carolina, lying and being situate on the westerly side of Wilshire Drive (formerly known as Brookwood Drive) within the limits of the City of Greenville, South Carolina, being known and designated as Lots #45, 46, and 47, Block "E" of Stone Estates, as per plat thereof recorded in the RMC Office for Greenville County, S. C. in Plat Book G, at page 292, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Westerly side of Wilshire Drive, said pin being 173.5 feet in a southerly direction from the intersection of Wilshire Drive with Camp Road, and running thence N. 78-38 W. 160 feet to an iron pin; thence S. 11-22 W. 75 feet to an iron pin; thence S. 78-38 E. 160 feet to an iron pin on the westerly side of Wilshire Drive; thence along Wilshire Drive N. 11-22 E. 75 feet to the point of beginning.
