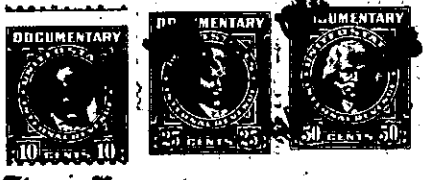

Know All Men by These Presents:

That we, Walter W. Goldsmith and R. M. Caine, in the State aforesaid, in consideration of the sum of One (\$1.00) Dollar and exchange of property, DOLLARS;

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released; and by these presents do grant, bargain, sell and release unto the said Walter S. Griffin, his heirs and assigns forever:

All our undivided two-thirds interest, the same being an undivided one-third interest each, in and to all that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the northeasterly side of Laurens Road, near the City of Greenville, S. C., in Pleasantburg Industrial Park, being more particularly shown on a plat of the property of R. M. Caine, W. W. Goldsmith and W. S. Griffin, made by Piedmont Engineering Service, dated June 20, 1962, which plat is recorded in the RMC Office for Greenville County, S. C. in Plat Book CCC, page 113, and having according to said plat the following metes and bounds, to-wit: BEGINNING at an iron pin on the northeasterly side of Laurens Road, said pin being located 190 feet in a northwesterly direction from the point of intersection of the center line of Industrial Drive with the northeasterly edge of the right-of-way of Laurens Road, and running thence along the northeasterly side of Laurens Road N 52-11 W 64.9 feet to an iron pin, corner of property of U. S. Government; thence with the line of the U. S. Government property N 15-07 E 173.9 feet to an iron pin on the southwesterly side of a 20 foot alley; thence with the southwesterly side of said alley S 51-54 E 133 feet to an iron pin; thence S 38-06 W 160 feet to an iron pin, the point of beginning.

This conveyance vests the entire fee of the above described property in the grantee, Walter S. Griffin.

As part of the consideration hereof the grantee does assume and agree to pay the entire remaining balance due on that certain mortgage given by the grantors and the grantee herein to General Mortgage Co., recently recorded in the RMC Office for Greenville County, S. C.

Also, as part of the consideration hereof the grantors do hereby assign, sell, transfer and set over unto the grantee, without recourse, all of their right, title and interest as landlords in and to any and all lease agreements covering the above described property.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

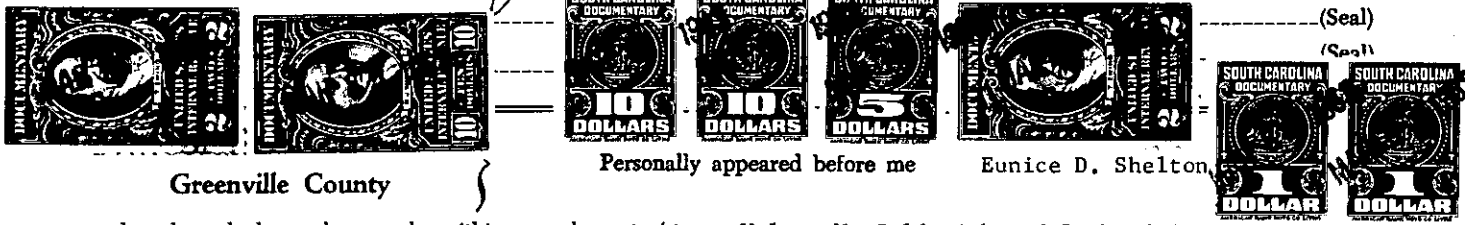
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.
