All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 1 as shown on a plat of Carver Court prepared by Piedmont Engineering Service dated March, 1955, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book II at page 107, and having according to a more recent plat prepared by J. C. Hill dated January 29, 1963, entitled "Property of Perlle Hill and Carrie S. Hill", the following metes and bounds:
