the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto JOSEPH R. BRYSON, his heirs and assigns:

ALL my right, title and one-half undivided interest in and to that certain piece, parcel or lot of land, with the buildings and improvements thereon, situate lying and being on the eastern side of Mallard Street in the city of Greenville, County and State aforesaid, having the following courses and distances:

BEGINNING at an iron pin on the eastern side of Mallard Street, which iron pin is 140 feet from Pendleton Street, at the corner of a lot now or formerly owned by Mrs. Iola C. Wyatt, and running thence with the line of the Wyatt property and parallel with Pendleton Street, 125 feet to an iron pin; thence in a southerly direction 50 feet to an iron pin; thence in a westerly direction 125 feet in a line parallel to Pendleton St., to an iron pin on Mallard Street; thence along the easterly side of Mallard Street in a northerly direction 50 feet to the beginning corner.
