KNOW ALL MEN BY THESE PRESENTS, that

D.C. Henderson and Robert Earle Henderson

in consideration of one(\$1.00) and 00/100----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Alvin R. Henderson, his heirs and assigns, forever!

All that piece, parcel, or lot of land situated in the County of Greenville, State of South Carolina, Grove Township and located on the northwest side of County Road, and having the following metes and bounds, to-wit:

Beginning at a point in County Road and thence N. 13-10 W. 360.5 feet to an iron pin; thence N. 86-56 W. 235.9 feet to an iron pin; thence along the line of Mildred H. Peden property, S. 35-55 W. 1504.6 to Stone O.; thence N. 80-40 E. 343 feet to point in said County Road; thence down said road N. 35-00 E. 100 feet; thence N. 49-40 E. 500 feet; thence N. 57-29 E. 180 feet; thence N. 51-56 E. 100 feet; thence N. 44-10 E. 100 feet; and thence N. 37-02 E. to the point of beginning in said road. Further reference is made to more exact and detailed description of said tract, containing 11.80 acres, more or less, to plat of C.O. Riddle, dated February 1963, and designated property of D.C. R.E. and Alvin R. Henderson.

This property is a part of a 68.37 acre tract conveyed to D.C. Henderson from E.F. Henderson, said deed recorded in Book of Deeds 138 at page 379, on date of Befruary 5th., 1930. D.C. Henderson conveyed subsequently an undivided 2/3 interest in said tract to Robert Earle Henderson and Alvin R. Henderson by deed recorded in Book of Deeds 518 at page 81, said deed is dated on January 30th., 1951. Alvin R. Henderson subsequently conveyed his undivided 1/3 interest in said tract to his wife, Ruth J. Henderson by deed recorded in Book of Deeds 625 at page 533, said deed is dated May 29th., 1959. Ruth J. Henderson subsequently died and devised her 1/3 interest in said tract absolutely to Alvin R. Henderson, said record of this Estate is filed in the Probate Court for Greenville County in Apartment 794, at page 17.
