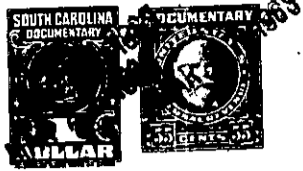

ALL that piece, parcel or lot of land in Highland Twp., Greenville County, State of South Carolina, Containing Five Acres, more or less, having the following Metes and Bounds:

BEGINNING at a point on Grantees' line N.17-30 W. 185 feet from corner in Tug-aloo Road, S.C.
