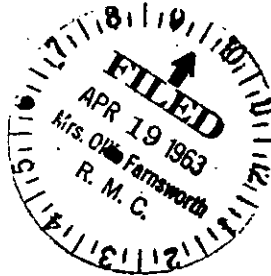

KNOW ALL MEN BY THESE PRESENTS, that I, M. W. Fore

in consideration of Two Hundred Ninety & NO/100 (\$290.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Mattie S. Pittman, her heirs and assigns forever:

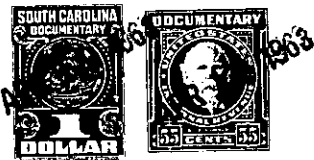
ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot 25, of a subdivision known as Holly Vista, as shown by a plat thereof, dated February 1956, recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 191, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Old Indian Trail, joint front corners of Lots 25 and 26 and running thence along the line of said lots, S. 31-12 W. 150 feet to iron pin rear corner of lots 31 and 32; thence running with rear line of lot 32, N. 58-48 W. 50 feet to iron pin on Holly Vista Drive; thence running with Holly Vista Drive, N. 31-12 E. 130 feet to iron pin; thence running at a curve, 28.7 feet to iron pin on Old Indian Trail; thence running with Old Indian Trail, S. 58-48 E. 30 feet to iron pin point of beginning.

NO residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet or more, frontage; no residence shall be built on any lot nearer than thirty (30) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS deed is made subject to all easements and rights of way of record.
