the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Walter F. Stokes and Shelby J. Stokes, Grantees, and their heirs and assigns forever, all of that certain lot of land in said State and County, O'Neal Township; near Locust Hill Baptist Church lying and being on the south side of Buncombe Road (surface treated) Now State Highway no. 415, and having the following courses and distances:

BEGINNING at an iron pin on the south side of Buncombe Road, now State Highway 415, corner of this lot and property of Corrie Ingram, formerly lands of Barbare Estate, and running thence with the south side of said road S. 49-47 E. 109 feet to iron pin on said road; thence S. 12-10 W. 290 feet along W.R. Revis line to iron pin; thence N. 56-25 W. 206.6 feet to iron pin on line of Corrie Ingram, formerly Barbare Estate; thence with the Ingram line N. 33-35 W.
