That I, J. Frank Williams

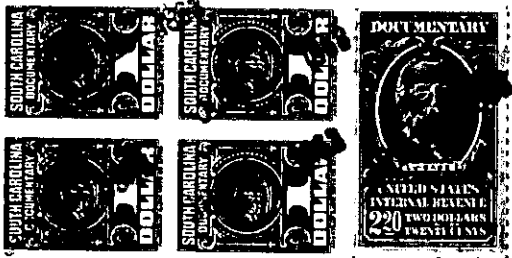
in consideration of the sum of Sixteen Hundred Sixty Five and no/100 (\$1665.00) - - DOLLARS, in the State aforesaid,
