All that lot of land, situate, lying and being on the Northwest side of Nottingham Road, near the City of Greenville, in Greenville County S. C., being shown as Lot No. 189 on plat of Sherwood Forest, made by Dalton & Neves, Engineers, August 1951, revised through June 1953, and recorded in the R. M. C. Office for Greenville County S.
