in consideration of Eight Hundred Seventy Five & NO/100 (\$875.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto J. J. Grooms and Martha H. Grooms, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, being known and designated as Lot No. 18, of a subdivision known as Bel Aire Estates, as shown on a plat thereof, dated May 1956, recorded in the R. M. C. Office for Greenville County in Plat Book KK, at Page 19, and having according to said plat the following metes and bounds, to-wit:

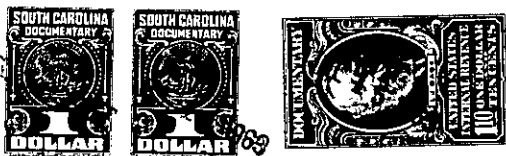
BEGINNING at an iron pin on Staunton Bridge Road, joint front corners of Lots 17 and 18 and running thence along the line of said lots, S. 88-21 E. 170 feet to iron pin rear line of Lot 20; thence running with line of said lot, S. 1-39 W. 58.5 feet to iron pin; thence running S. 43-15 W. 23.4 feet to iron pin rear corner of Lot 19; thence running with line of said lot, N. 88-21 W. 117.8 feet to iron pin on Staunton Bridge Road; thence running with Staunton Bridge Road, N. 1-39 E. 75 feet to iron pin point of beginning.

NO residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet or more frontage; no residence shall be built on any lot nearer than thirty-five (35) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; no business buildings shall be erected on any lot other than lots fronting on Staunton Bridge Road.

THIS conveyance is subject to all easements and rights of way of record.

GRANTEE to pay 1963 taxes.

It is expressly understood by the parties hereto that this deed has been executed pursuant to a Contract of Sale heretofore entered into between the parties. However the South Carolina Highway Department has a portion of this lot for highway purposes this deed is executed with full knowledge.
