and assumption of mortgage described below,

All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, being known and designated as Lot No. 11 of a subdivision known as Springview as shown on a plat thereof recorded in the RMC Office for Greenville County in Plat Book BB, at page 161, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Farley Avenue at the joint corner of Lots Nos. 10 and 11; and running thence with the line of said lots, N. 4 W. 93.8 feet to an iron pin, joint corner of Lots Nos. 11 and 12; thence with the joint line of said lots S. 89-22 E. 150 feet to an iron pin on the western side of Bryon Court; thence with Bryon Court S. 0-38 W. 90.4 feet to an iron pin; thence in a curved line around the intersection of Byron Court and Farley Avenue, the arc of which is S. 48-29 W. 33.5 feet to an iron pin on the northern side of Farley Avenue; thence with Farley Avenue N. 83-40 W. 40.7 feet and N. 77-40 W. 78 feet to the beginning.

As a part of the consideration hereof, the Grantee assumes and agrees to pay, according to its terms, that certain note and mortgage given to First Federal Savings & Loan Association on which there is a balance due of \$4,902.12, said mortgage being recorded in Mortgages Volume 886 page 50.
