Gilstrap, his heirs and assigns forever,**

All that lot of land in Greenville County, State of South Carolina, on the Northern side of the turn around of Hampton Court, near the City of Greenville, being shown as Lot 11 on a plat of Section 2 of Wade Hampton Gardens, recorded in Plat Book DDD at page 54, and described as follows:

BEGINNING at an iron pin on the Northern side of the turn around of Hampton Court at the corner of Lot 10, and running thence with the Northern side of the curve of said turn around, the chords of which are N. 21-00 E. 30 feet, N. 73-46 E. 40 feet and S. 63-28 E. 30 feet to an iron pin at the corner of Lot 12; thence with the line of said lot, N. 23-20 E. 142.1 feet to an iron pin in line of Lot 7 of Wade Hampton Gardens No. 1, and running thence with the lines of Lots 7 and 8, N. 63-16 W. 218.65 feet to an iron pin; thence S. 18-23 W. 119.8 feet to an iron pin at the corner of Lot 10; thence with the line of said lot, S. 35-11 E. 172.6 feet to the Beginning corner.
