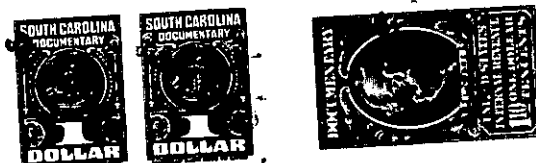
Henry C. Harding, his heir's and assigns forever:

All that certain piece, parcel or lot of land lying and being on the easterly side of Michael Drive, near the City of Greenville, S. C., and being designated as Lot No. 7 on plat entitled Michael Park, as recorded in the RMC Office for Greenville County, S. C. in Plat Book XX, page 21, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Michael Drive, joint front corner of Lots 7 and 8, and running thence along the common line of said lots S 59-20 E 158 feet to an iron pin; thence S 30-56 W 72.4 feet to an iron pin, which pin is located 20 feet from the northerly side of an existing unnamed street 10 feet wide (said 20 feet being reserved for road purposes); thence N 65-42 W 138.5 feet to an iron pin; thence on a curve the chord of which is N 17-28 W 26.6 feet to an iron pin on the easterly side of Michael Drive; thence along said Drive N 30-46 E 70 feet to an iron pin, the point of beginning.

This conveyance is made subject to existing easements and rights-of-way affecting said lot, including those shown on the aforementioned recorded plat, and is also subject to a 35 foot building setback line as shown on said plat.
