That I, J. Frank Williams

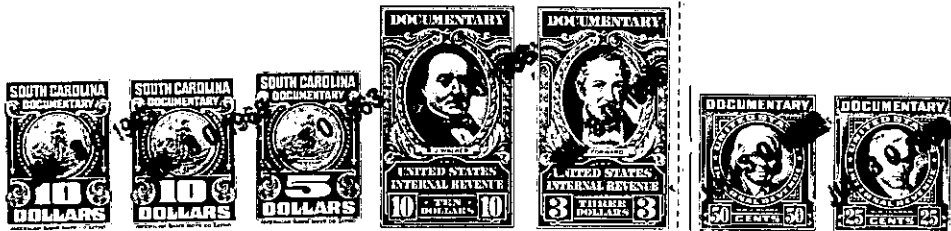
in consideration of the sum of Twelve Thousand Five Hundred and no/100 (\$12,500.00) DOLLARS, in the State aforesaid,
