the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto **Eva B. Moody, her heirs and assigns forever,**

ALL that tract or lot of land in Greenville Township, Greenville County, State of South Carolina, on the Eastern side of Dunham Bridge Road, being known and designated as Lot No. 10, and on the Northern half of Lot No. 11 according to plat of property of Thomas Clifton Collins made by W. J. Riddle, Surveyor, August 1945, and having, according to said plat, the following metes and bounds, courses and distances, to-wit:-
