A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of Forty Seven Hundred Two and 50/100----- Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto Augustine A. Ohmsen and Jean H. Ohmsen, their heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 15 of a subdivision known as "ADDITION TO WILDAIRE ESTATES", according to a plat thereof prepared by Piedmont Engineering Service, November 1962, and recorded in the R.M.C. Office for Greenville County in Plat Book RR, at Page 100, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the eastern side of Ramblewood Drive, the joint front corner of lots #15 and #16, and running thence along the line of these lots, N. 75-30 E. 184.5 feet to an iron pin at the joint rear corner of lots #15 and #16; running thence S. 7-41 E. 62.3 feet to an iron pin; thence continuing S. 7-34 E. 50.4 feet to an iron pin at the joint rear corner of lots #15 and #14; running thence along the joint line of these lots, S. 79-30 W. 176.2 feet to an iron pin on the eastern side of Ramblewood Drive; thence along the eastern side of Ramblewood Drive, N. 11-53 W. 100.0 feet to an iron pin, point of beginning.
