to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents a grant, bargain, sell and release unto the said

Gladys Good, Grantee, and her heirs and assigns forever, all of that certain lot of land in said State and County, Glassy Mountain Township, about three miles West from Glassy Mountain Baptist Church, lying and being on the East side of a dirt road leading up to Glassy Rock, bounded by lands of Lewis Pittman on the West, South by lands of Ernest Pittman on the East, by lands of Grantor and by said Dirt Road, and having the following courses and distances.;

BEGINNING at an iron pin on the West side of said dirt road, Lewis Pittman corner and runs thence partly with Lewis Pittman line and other land of grantor in an easterly direction 200 feet to iron pin on Ernest Pittman line; thence in a northerly direction with Ernest Pittman 150 feet to another pin on said line; thence in a westerly direction 200 feet to iron pin on east bank of said dirt road; thence with said dirt road in a southerly direction 200 feet to iron pin, the beginning corner, and being a part of the same tract of land conveyed to me by Thurman Pittman about six or seven years ago.
