the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release

CLARENCE W. ORR, JR, and WILMA D. ORR, their heirs and assigns forever:

All that lot of land situate in Greenville County, South Carolina on the southern side of Elf Lane being shown and designated as Lot No. 74 on a Plat of an extension of Sharon Park, made by C. C. Jones, a civil engineer, dated December, 1962, and recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book CCC, Page 71, and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Elf Lane at the joint front corners of Lots Nos. 73 and 74, and running thence S. 4 - 30 W. 153.1 feet to an iron pin; thence N. 89 - 49 E. 86 feet to an iron pin, joint rear corner of Lots Nos. 74 and 75; thence N. 4 - 30 E. 146.6 feet to an iron pin on the southern side of Elf Lane; thence with the southern side of Elf Lane N. 85 - 30 W. 85 feet to an iron pin, the beginning corner.

The above described property is hereby conveyed subject to utility rights-of-way and easements of public record and to Restrictive Covenants applicable to Sharon Park Extension recorded in the R. M. C. Office for said County and State in Deed Book 716, Page 209.

As a part of the consideration for this deed, the grantees herein do hereby assume and agree to pay in full the balance due at the date hereof on that certain mortgage given by Henry C. Harding to Carolina Federal Savings and Loan Association of Greenville, South Carolina which now exists as a first mortgage lien upon the premises and which appears of public record in the R. M. C. Office for said County and State, reference to which is hereby craved.
