Route It was subsequently determined by the grantor that all of said right-of-way would not be required for road purposes and it is the intention of this deed to release and quitclaim the interest of the South Carolina Highway Department in and to said Right of Way Easement which has not been used for road purposes. Subsequent to said execution of said Right of Way Easement, the grantors therein conveyed all of their property rights in said property to The McAlister Corp., which is now the owner of said property hereinabove described.
