 these presents do grant bargain, sell and release unto the said Hazel C. Edwards, her heirs
 and assigns forever:-

all that piece, parcel or lot of land in O'Neal Township, Greenville
 County, State of South Carolina, and being all of lots numbers 1, 2, 3, 4; and 6, 7,
and 8 as shown on plat for W. H. Campbell by J. Q. Bruce, 10-5-62, and
 having the following courses and distances, to-wit:-

As to lots Nos. 1, 2, 3 and four, together:
 Beginning at the joint front corner of Nos. 4 and 5 lots, on line of
W. H. Campbell, and runs thence with his line, N 29-53 W one hundred
 twenty-nine and six-tenths (129.6) feet to an old iron pin; thence N
 51 E two hundred twenty-five and five-tenths (225.5) feet to iron pin
 (old) at angle; thence N 35-45 two hundred twenty-five (225) feet to
 iron pin at corner Lot #1; thence same course, one hundred sixty-
 and eight-tenths (160.8) feet to iron pin; thence N 8-05 W two hundred
 seventy-two (272) feet to iron pin on edge of road; thence with said
 road, S 49-49 W two hundred sixty-two and six-tenths (262.6) feet to an
 iron pin on line of lot #3; thence S 20-11 E two hundred forty-six and
 nine-tenths (246.9) feet to corner of lot #5; thence as dividing Nos. 4
 and 5 lots, N 71-48 E two hundred forty-six and three-tenths (246.3)
 feet, the beginning corner.

As to lot Nos. 6, 7 and 8, together:-
 Beginning at the joint corner of Nos. 9 and 8 lots on line of W. H. Campbell,
 and runs thence with his line, N 29-53 W three hundred ten and
 eight-tenths (310.8) feet to corner of lot No. 5; thence as dividing Nos. 5
 and 6 lots, N 71-28 W two hundred two hundred twenty-eight ~~15~~/~~10~~ feet
 to iron pin on road; thence with said road, S 20-11 E three hundred
 (300) feet to corner lot No. 9; thence N 69-49 E one hundred seventy-six
 and three-tenths (176.3) feet, the beginning corner.
