to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Grace D. Revis, her heirs and assigns forever:

ALL MY UNDIVIDED RIGHT, TITLE, AND INTEREST in and to all that certain parcel or lot of land situate, lying and being in O'Neal Township, Greenville County, State of South Carolina, on the North side of Groce Meadow Road, about one mile Northwest of Milford Baptist Church, containing 0.74 acre, more or less, and having the following metes and bounds:

BEGINNING on a nail and stopper on edge of Groce Meadow Road, and running thence with an old abandoned road, S 74-50 E 205 feet to an iron pin in said road; thence N 38-10 W 31 feet to a stake on bank of said abandoned road; thence continuing with the same course for a total distance of 340 feet to an iron pin in an open field; thence S 42-15 W 149.5 feet to a nail and stopper in center of Groce Meadow Road (iron pin back on line at 21 feet); thence with Groce Meadow Road, S 47-45 E 152.5 feet to the point of beginning.

The above described property being identically the same conveyed Mack Revis and Grace Revis by deed dated April 24, 1953, recorded in Vol. 480 page 407. Mack Revis died intestate August 8, 1963. See record Greenville County Probate Court.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
