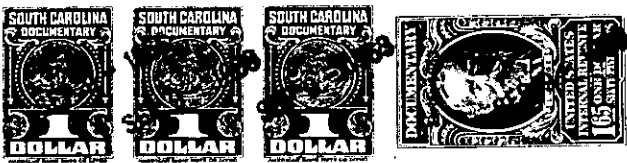
KNOW ALL MEN BY THESE PRESENTS, that we, Hazel Burnside and Lula Mae Waller
